DEFINITIONS

In these Competition Regulations, capitalised terms shall have the following meanings, unless the context specifically indicates otherwise:

Accommodation	Any location approved by the CAFA which provides accommodation to the CAFA Delegation, Team Official Delegations, CAFA
Accreditation Card	Commercial Rights Partner, and Commercial Affiliates. Any physical item which is issued by the CAFA and/or Organising Association which provides the recipient the right to access a Controlled Access Area (or part thereof) where the Controlled Access Area is under the control of the CAFA or the Organising Association.
Advertising Rights	The right to promote brand and/or corporate names and/or products and/or services at and/or in relation to the Competition by whatever means available, whether existing now or to be developed in the future, whether at the Stadiums or Facility Areas or within the Controlled Access Areas, by instadium/out-stadium perimeter signage and other advertising, digital signage and screens, closed circuit television, equipment usage or other methods and through printed matter (including digitally delivered printed matter) such as programmes, posters, letterheads, press releases, newsletters and Tickets, and subject to any relevant CAFA and/or AFC regulations, the right to display such advertising on the clothing or footwear worn, or on any equipment used, carried or transported by officials (including for the avoidance of doubt Match Officials), medical and security staff, ball kids, player escorts, flag bearers and/or photographers. The display of the name and/or logo of the bona fide supplier of clothing on the strip of the uniforms of the officials are also included. For the avoidance of doubt, advertising on the strip of Participating Players is excluded, other than where it is the trademark of the bona fide manufacturer and is in accordance with any FIFA and/or AFC regulations. Similarly, branding on any equipment, goods and/or services used in connection with the Competition, save where supplied by a Commercial Affiliate, may only include customary branding of the bona fide manufacturer.

Ticket	A pass providing access to a venue for the purpose of attending either a Match, official training, or Official Function.

For the purposes of these Regulations, and provided the context so permits:

- (a) the singular shall include the plural and vice-versa;
- (b) the feminine gender shall include the masculine and vice-versa;
- (c) reference to natural persons shall include any legal person or corporation;

(d) references to the CAFA shall include its successors and permitted assigns and its respective Member Associations and CAFA Committees;

(e) reference to the CAFA Commercial Rights Partner or Commercial Affiliates shall include where advised by the CAFA, its successors, and permitted assigns;

(f) all defined terms, unless otherwise stated herein shall bear the same meaning as ascribed in the CAFA Statutes, unless the context indicates otherwise.

SECTION 1: GENERAL PROVISIONS

1. CAFA Futsal Cup 2023

- 1.1. CAFA Futsal Cup 2023 is organized by Central Asian Football Association;
- 1.2. These Regulations govern the rights, duties, and responsibilities of the CAFA, Organizing Association, Member Associations, Participating Teams, Participating Players and Participating Officials taking part in the Competition.
- 1.3. These Regulations and all related directives, decisions, match protocols, guidelines, and circulars issued by the CAFA shall be binding upon all parties participating and involved in the preparation, organization, and hosting of the Competition.
- 1.4. The AFC Competition Operations Manual ("Manual") forms an integral part and shall be read in conjunction with these Regulations. The Manual shall be binding upon all parties participating and involved in the preparation, organisation and hosting of the Competition.
- 1.5. Any rights and Proprietary Interests associated with the Competition that are not granted by these Regulations and/or specific agreements to any Organising Association or Participating Member Association shall vest in the CAFA.
- 1.6. Each Member Association shall be represented at the Competition by only one Participating Team.

2. The Central Asian Football Association

- 2.1 The CAFA General Secretariat shall carry out the necessary administrative work in preparation for the Competition.
- 2.2. The responsibilities of the CAFA shall include, but are not limited to:
 - 2.2.1. supervising general preparations and deciding on the Competition format, the draws, and the entries to the Competition;
 - 2.2.2. determining the Match Schedule;
 - 2.2.3. selecting Indoor Stadiums for the Competition (cf. Article 13);
 - 2.2.4. appointing Match Officials for each Match;
 - 2.2.5. choosing and/or approving the official futsal balls and stipulated technical material;
 - 2.2.6. replacing Participating Teams that have withdrawn from the Competition (cf. Article 6);
 - 2.2.7. dealing with cases of cancelled Matches or abandoned Matches (cf. Articles 11 and 12);
 - 2.2.8. dealing with cases of Force Majeure (cf. Article 64);

- 2.2.9. dealing with any other aspect of the Competition that is not the responsibility of any other body pursuant to these Regulations or the CAFA Statutes (cf. Article 65).
- 2.3. All decisions made by the CAFA Competitions Committee and/or CAFA General Secretariat in relation to the Competition are final and binding and not appealable.

3. Organising Association

- 3.1. The principal obligations and responsibilities of any Organising Association are stipulated in the (where relevant) Organising Association Agreement ("OAA"), these Regulations, the Manual, the CAFA Statutes and all other CAFA regulations, directives, guidelines and circulars.
- 3.2. The Organising Association shall undertake, at its own cost, to:
 - 3.2.1. observe all obligations set out in the (where relevant) OAA, these Regulations, the Manual, the CAFA Statutes and all other CAFA regulations, directives, guidelines and circulars and all applicable national and supra-national laws;
 - 3.2.2. perform each of its obligations and exercise each of the rights granted to it as host, in connection with the hosting, staging and organisation of the Competition in accordance with professional standards;
 - 3.2.3. assist and coordinate with Member Associations on all arrangements relating to the Competition in agreement with the CAFA;
 - 3.2.4. negotiate with and/or lobby the appropriate government bodies and/or local authorities to assist for the successful hosting, staging and organising of the Competition;
 - 3.2.5. obtain all applicable and relevant licenses, permits, grants and authorisations as may be required to fulfil its obligation in relation to the hosting, staging and organising of the Competition;
 - 3.2.6. comply with the CAFA's instructions on the provision of key services, facilities, equipment and infrastructure at eachInddor Stadium;
 - 3.2.7. provide the necessary assistance and support to the CAFA, CAFA Commercial Rights Partner and Commercial Affiliates in relation to the use and exploitation of the Commercial Rights and all Proprietary Interests of the CAFA and the protection and enforcement of rights in relation thereto;
 - 3.2.8. procure all necessary insurance policies which shall provide coverage for all risks relating to the hosting, staging and organising of the Competition and name the CAFA as a co-insured;

- 3.2.9. obtain all clearances and executing all required documentation to enable the free and unfettered exercise and exploitation of Commercial Rights and clearance of all products, equipment or materials relating to the exploitation of the Commercial Rights of the Competition; and
- 3.2.10. guarantee safety and security at the Indoor Stadium.
- 3.3. Each Organising Association shall indemnify, hold harmless and defend the CAFA, the CAFA Commercial Rights Partner, its Commercial Affiliates as well as their officers, members, agents, auxiliary persons, representatives, and employees from and against all liabilities, obligations, damages, losses, claims, demands, recoveries, deficiencies, costs or expenses (including without limitation all costs and expenses for finding and contracting with another Organising Association able and willing to stage the Competition and/or all attorneys' fees and expenses) which such parties may suffer or incur in connection with, resulting from, or arising out of any breach by the Organising Association (including its officers, directors, representatives, auxiliary persons, employees or agents) or any act or omission of the Organising Association (including its officers, representatives, auxiliary persons, employees or agents) in connection with the performance of its obligations under this Agreement.

4. Participating Member Associations

- 4.1. The principal obligations and responsibilities of each Participating Member Association are stipulated in these Regulations, the Manual, the CAFA Statutes, and all other CAFA regulations, directives, guidelines and circulars
- 4.2. Each Participating Member Association shall undertake to:
 - 4.2.1. observe all obligations set out in these Regulations, the Manual, the CAFA Statutes, and all other CAFA regulations, directives, guidelines and circulars, and applicable national and supra-national laws;
 - 4.2.2. comply with the Futsal Laws of the Game laid down by the FIFA;
 - 4.2.3. accept that all the administrative, disciplinary and refereeing matters connected with the Competition shall be settled by the CAFA in compliance with these Regulations;
 - 4.2.4. field their strongest team throughout the Competition;
 - 4.2.5. observe the principles of Fair Play;
 - 4.2.6. ensure the good conduct of its Team Official Delegation and of any person carrying out duties on its behalf throughout the Competition, which includes

but is not limited to their arrival on the territory of any Organising Association until their departure;

- 4.2.7. accept all arrangements made by any Organising Association in agreement with the CAFA;
- 4.2.8. ensure that Participating Players and Participating Officials attend and participate in all official activities and events, including without limitation any team arrival meeting, match coordination meeting, press conferences, and other media and marketing activities in accordance with the instructions issued by the CAFA;
 - 4.2.8.1. failure to attend and/or fully participate in any official activity or event shall result in the Participating Member Association being fined at least USD 5,000; and
 - 4.2.8.2. the CAFA Disciplinary and Ethics Committee may issue further sanctions in its discretion.
- 4.2.9. provide to the CAFA, free of charge, prior to the Competition, any photographs, audio/visual materials and/or information regarding the Participating Member Association, Participating Team, Participating Player and/or Participating Officials including without limitation statistics and historical information and any further information as requested by the CAFA;
- 4.2.10. not establish any digital, media or social media platform without the involvement and express approval of the CAFA.
- 4.3. Each Participating Member Association shall, at its own expense, be solely responsible throughout the Competition for:
 - 4.3.1. the procurement of insurance coverage of its Team Official Delegation which shall include without limitation hospital and surgical insurance, travel insurance, and/or sports equipment insurance for all Matches;
 - 4.3.2. all other necessary insurance policies, which must provide an appropriate guaranteed sum for injury and damage to persons, objects, and property, and correspond with the specific circumstances of the Participating Member Association's participation in the Competition. The CAFA must be notified of all insurance policies, and may request copies of any and all policies at its discretion;
 - 4.3.3. payment of incidental expenses and for any costs incurred by its Team Official Delegation (cf. Article 21);
 - 4.3.4. payment of any costs of extending the stay of any member of its Team Official Delegation in any Organising Association (cf. Article 21);

- 4.3.5. payment of all taxes, fees, duties and any other costs related to the importation and/or exportation of equipment, merchandise and/or goods to be used for the Competition.
- 4.4. Each Participating Member Association shall indemnify, defend, and hold the CAFA and all of its officers, directors, employees, representatives, agents, and all other auxiliary persons free and harmless against any and all liabilities, obligations, losses, damages, penalties, claims, actions, fines, and expenses (including reasonable legal expenses) of whatsoever kind or nature resulting from, arising out of, or attributable to, any non-compliance with these Regulations by the Participating Member Association, their Team Official Delegation, their affiliates and any third-parties contracted to the Participating Member Association.
- 4.5. Each Participating Member Association shall ensure that any decision made by the CAFA relating to its duties and responsibilities is enforced immediately.

5. Entry

- 5.1. Member Associations shall participate in the Competition by virtue of:
 - 5.1.1. being a Member of CAFA; and/or
 - 5.1.2. being invited by the CAFA to participate in the Competition.

6. Withdrawal from the Competition

- 6.1. All Participating Member Associations undertake that their Participating Teams shall play all of their Matches in the Competition.
- 6.2. In the case of a Participating Member Association withdrawing or being excluded from the Competition, the CAFA General Secretariat shall be responsible for making any decisions, including without limitation whether to:
 - 6.2.1. replace the Participating Member Association;
 - 6.2.2. change the competition system (cf. Article 7); and/or
 - 6.2.3. change the technical rules (cf. Section 4).
- 6.3. All decisions of the CAFA General Secretariat in this regard are final and binding and not appealable.
- 6.4. Any Participating Member Association that:

- 6.4.1 informs the CAFA in writing that it does not intend to or is unable to report to a Venue and/or for a Match;
- 6.4.2. does not report to a Venue and/or for a Match; or
- 6.4.3. refuses or fails to continue a Match; or
- 6.4.4. leaves the Indoor Stadium prior to the completion of a Match;
- 6.4.5. is excluded, suspended or banned by any competent body from participating in any Match in the Competition at any time after the relevant Match has been scheduled,

shall be considered to have withdrawn from the Competition and shall:

- 6.4.6. have all its Matches canceled and considered null and void. For the avoidance of doubt, all points and goals in those Matches shall not be taken into consideration when determining the final rankings in a group pursuant to Article 7.4;
- 6.4.7. be required to pay compensation for any and all damages or losses suffered by, where applicable, the other Participating Member Associations, the CAFA, the CAFA Commercial Rights Partner, Commercial Affiliates, and the Member Associations. The amount of compensation shall be determined by the CAFA General Secretariat and/or CAFA Executive Committee.
- 6.5. Subject to Articles 6.4. the CAFA Executive Committee shall be responsible for making the necessary decisions where a Participating Member Association withdraws from the Competition at any stage, whether before or after its commencement, and shall be entitled to take any action it considers appropriate in such circumstances.
- 6.6. Any Participating Member Association that withdraws from the Competition at any stage shall also be referred to the CAFA Disciplinary and Ethics Committee. The CAFA Disciplinary and Ethics Committee may impose additional sanctions to those provided for under Articles 6.4 and 6.5 at its discretion.
- 6.7. The above Articles 6.2 to 6.6 are not applicable in cases of Force Majeure recognised by the CAFA General Secretariat. The CAFA General Secretariat shall take whatever action it deems necessary in cases of Force Majeure.

SECTION 2: COMPETITION SYSTEM AND MATCH SCHEDULE

7. Competition System

- 7.1. The Competition shall be played in a single round-robin format (all play all). The CAFA shall decide on the teams' positions before the fixtures are made.
- 7.2. In the case of last-minute withdrawal by one (1) Participating Country, a re-draw shall be carried out to decide the new capacity of the Group if deemed necessary. The CAFA has the right to carry out the draw and/or redraw if necessary.
- 7.3. At the conclusion of each Match:
 - 7.3.1. Three (3) points shall be awarded to the winner;
 - 7.3.2. One (1) point shall be awarded to each Participating Team for a draw;
 - 7.3.3. Zero (0) points shall be awarded to the loser.
- 7.4. The winner, runner-up and 3rd placed team of the Competition shall be determined as follows:
 - 7.4.1. Higher number of points obtained in all group Matches;
 - 7.4.2. If two (2) or more Participating Teams are equal on points, the following criteria are applied to determine the ranking (in descending order):

Head-to-Head criteria

7.4.2.1. Higher number of Points obtained in the group Matches played between the Participating Teams in question;

7.4.2.2. superior goal difference from the group Matches played among the Participating Teams in question;

7.4.2.3. higher number of goals scored in the group Matches played among the Participating Teams in question;

<u>Tiebreaker</u>

7.4.2.4. if, after having applied the Head-to-Head criteria, two (2) or more Participating Teams still have an equal ranking, the Head-to-Head criteria shall be reapplied exclusively to the Matches between the Participating Teams in question to determine their final rankings. If this procedure does not lead to a decision, the Group Results criteria shall apply;

Group Results criteria

7.4.2.5. superior goal difference from all group Matches played;

7.4.2.6. higher number of goals scored from all group Matches played;

7.4.2.7. Kicks from the Penalty Mark if only two (2) Participating Teams still have an equal ranking and have played their last group Match against each other;

7.4.2.8. The lower score calculated according to the number of yellow and red cards received in group Matches (Appendix 1 of the Manual); or

7.4.2.9. The drawing of lots.

Drawing of lots

- 7.5. If a drawing of lots is required to decide the ranking in a group, the following principles shall apply:
 - 7.5.1. The names of Participating Teams in question shall be placed into a pot;
 - 7.5.2. The first name drawn shall be the highest-ranked of the Participating Teams in question;
 - 7.5.3. If necessary and subject to the number of Participating Teams concerned, the procedure shall be repeated to determine the rankings of all Participating Teams concerned.

8. Seeding

- 8.1. CAFA will use teams ranking published at the Futsal World Ranking (https://www.futsalworldranking.com/rank.htm) as of 23 June 2023 to identify teams positions while seeding.
- 8.2. Organizing Association, as the Host Country, shall have the privilege of being positioned as A1 team.

9. Match Schedule

- 9.1. All Matches shall be played in accordance with the CAFA Competitions Calendar. The dates are final and binding and not appealable.
- 9.2. The CAFA General Secretariat retains final discretion to amend the Match Schedule at any time.

10. Delay of Kick-off

10.1. A Participating Team that causes a delay of any scheduled Kick - off of a Match (as determined by the Official Countdown) may be sanctioned by the relevant CAFA Committee in its discretion. For the avoidance of doubt delay to kick-off includes delay to start of both periods (i.g. the first half and second half) of a Match.

11. Cancellation of Matches

- 11.1. If a Match cannot commence for any reason, the following procedure shall be followed in cases where the Match in question was not cancelled prior to a Match day:
 - 11.1.1. The Match must be delayed for a minimum of thirty (30) minutes. During this delay, the Referee may decide whether the Match can commence prior to the completion of the delay;
 - 11.1.2. following the first delay, either:

11.1.2.1. An additional delay of thirty (30) minutes shall occur if in discretion of the Referee this second delay may allow the Match to commence; or

- 11.1.2.2. The Match shall be declared cancelled by the Referee;
- 11.1.3. Following two (2) delays of thirty (30) minutes, the Referee must declare the Match cancelled.
- 11.2. For any Match which is cancelled as a result of Force Majeure, the CAFA General Secretariat shall decide on the matter at its sole discretion and take whatever action is deemed necessary.
 - 11.2.1 Decisions made pursuant to Article 11.2. are final and binding and not appealable.
- 11.3. Any Match which is cancelled, except in cases of Force Majeure recognized by the CAFA General Secretariat, may lead to the imposition of sanctions by the relevant CAFA Committee against the relevant party that has caused the cancellation of a Match in accordance with the CAFA Disciplinary and Ethics Code.

12. Abandonment of Matches

- 12.1. At any stage of a Match, if a Participating Team is only able to field fewer than three (3) players, the Match shall be abandoned and Article 12.4 shall apply.
- 12.2. If a Match is stopped by the referee for any other reason except for that set out in Article 12.1, the following procedure shall be followed:
 - 12.2.1. the Match is stopped for thirty (30) minutes. During this stoppage, the referee may decide that the Match can commence prior to the completion of the stoppage;
 - 12.2.2. subsequent to the first stoppage, either:

12.2.2.1. an additional stoppage of thirty (30) minutes shall occur if at the discretion of the referee this second stoppage may allow the Match to be resumed; or

- 12.2.2.2. the Match is declared abandoned by the referee.
- 12.2.3. following two (2) stoppages of thirty (30) minutes, the referee must declare the Match abandoned.
- 12.3. Should the CAFA determine that an abandoned Match should be rescheduled and completed, the following principles shall apply:
 - 12.3.1. the Match shall recommence with the same score and from the minute at which it was interrupted rather than being replayed in full;
 - 12.3.2. the Match shall recommence with the same Participating Players on the Field of Play and same substitutes at the time when it was initially abandoned;
 - 12.3.3. no additional substitutes may be added to the Player Selection List or Match Starting List;
 - 12.3.4. any Participating Player sent off during the abandoned Match cannot be replaced;
 - 12.3.5. any sanction imposed before the Match was abandoned remain valid for the remainder of the rescheduled Match;
 - 12.3.6. the Kick-off time, date and Stadium of the re-scheduled Match shall be decided by the CAFA; and
 - 12.3.7 any other matters not set out above shall be decided by the CAFA General Secretariat at its sole discretion.
- 12.4. If a Match is stopped by the referee before the end of normal playing time or during any Extra Time as a result of a Participating Team being able to only field fewer than three (3) Participating Players, the Match shall be declared abandoned and the Participating Team who is able to field more than three (3) Participating Players shall be declared the winner by the score 5-0, or the score at the time of abandonment, whichever is higher.
- 12.5. For any Match which is abandoned as a result of Force Majeure, the CAFA General Secretariat shall decide on the matter at its sole discretion and take whatever action is deemed necessary.

12.5.1. Decisions made pursuant to Article 12.5. are final and binding and not appealable.

12.6. Any Match which is abandoned, except in cases of Force Majeure recognized by the CAFA General Secretariat, may lead to the imposition of sanctions by the CAFA Disciplinary and Ethics Committee against the relevant party that has caused the abandonment in accordance with the CAFA Disciplinary and Ethics Code.

SECTION 3: INDOOR STADIUMS AND OFFICIAL TRAINING SITES

13. Indoor Stadiums

- 13.1. The Organizing Association shall ensure that all Matches in the Competition are played in Indoor Stadiums which meet the requirements defined in the AFC Futsal and Beach Soccer Stadium Regulations and any other applicable AFC regulation. The CAFA General Secretariat may carry out inspections at any time before and during the Competition to check whether the requirements are met.
- 13.2. Smoking is strictly prohibited within any Indoor Stadium, and in particular, in the technical area, the vicinity of the Field of Play, or within Competition functional areas which include, without limitation, the teams' dressing rooms.

14. Official Training Sites

- 14.1. The Organizing Association shall nominate the Official Training Sites which shall contain necessary equipment and training pitch prepared to Match-condition. They shall be treated as the Official Training Sites for the Participating Teams for the duration of the Competition.
- 14.2. Official Training Sites shall be made available at least five (5) days prior to the first Match in the Venue. They shall not be used for any other purpose during this period, unless written permission has been obtained from the CAFA.
- 14.3. Participating Teams must solely utilize Official Training Sites for any official training from two (2) days prior to their first Match.

15. Official Training at the Indoor Stadium

- 15.1. Each Participating Team is entitled to an official training of forty-five (45) minutes duration in the Indoor Stadium in which they are due to play either one (1) or two (2) days prior to their first Match in the Indoor Stadium in the Competition.
- 15.2. Each official training session shall be open at least for the first fifteen (15) minutes. The areas accessible by the Media (if any) shall be the same as the areas accessible for them during the Match, provided that they are in possession of valid accreditation. Such areas shall be strictly controlled by the Host Organisation.
- 15.3. The official training session shall only commence at the time and run for the duration determined and approved in writing by the CAFA. Participating Players are prohibited from entering the pitch prior to the scheduled time for the official training.
- 15.4. The CAFA shall determine the official training schedule for the Participating Teams at its discretion. Participating Teams shall strictly follow the official training schedule

determined by the CAFA. Any request from the Participating Teams to change the schedule of the official training must be submitted to the CAFA at least twelve (12) hours prior to the relevant training session. If a Participating Team wishes to cancel any official training, they shall provide twelve (12) hours prior notice to the CAFA.

SECTION 4: TECHNICAL REGULATIONS

16. Match Officials and Refereeing

- 16.1. The CAFA Delegation for the Competition shall be appointed by the CAFA respective committee(s) and/or CAFA General Secretariat.
- 16.2. If one of the two (2) Referees is prevented from carrying out his/her duties, such Referee shall be replaced by the Third Referee.

17. Futsal Laws of the Game

- 17.1. All Matches shall be played in accordance with the Futsal Laws of the Game in force and as laid down by FIFA. In the case of any discrepancy in the interpretation of the Futsal Laws of the Game, the English version shall prevail.
- 17.2. Each Match shall last forty (40) minutes, comprising two (2) periods of twenty (20) minutes, with a half-time interval of fifteen (15) minutes.
- 17.3. The nine (9) substitutes listed on the Match Start List may take part in the Match. An unlimited number of substitutions maybe made during a Match.
- 17.4. The Participating Teams are entitled to one (1) timeout period, consisting of one (1) minute each. Participating Officials are authorised to submit a request for timeout to the Third Referee or Timekeeper (if there is no Third Referee) using the form provided by the CAFA.

18. Match Operations Protocol During COVID-19 Pandemic

- 18.1. Depending on the epidemiological situation in the world all matches of the Competition shall be played in accordance with the CAFA Match Operations Protocol During COVID-19 Pandemic (Edition 2021) unless otherwise decided by the CAFA General Secretariat.
- 18.2. CAFA Match Operations Protocol During COVID-19 Pandemic (Edition 2021) forms an integral part of these Regulations.

19. Team Bench and Technical Area

- 19.1. A maximum of nine (9) Participating Players and a maximum of six (6) Participating Officials are permitted to sit on the team bench during a Match, provided they are in possession of the appropriate Accreditation Card.
- 19.2. All individuals on the team bench must wear kits that contrast with the kits of the Participating Players and Match Officials present on the Field of Play. This kits must comply with the AFC Equipment Regulations.

19.3. Individuals serving a Match suspension, non-selected Participating Players, and Participating Officials part of the Team Official Delegation but not listed in the "Officials on the Team Bench Form" are not permitted to enter the Field of Play and/or sit on the Team bench. They may sit at the designated area in the stands reserved for the Team Official Delegations.

20. Futsal Balls

- 20.1. The futsal balls used in the Competition shall be selected and supplied by the Organizing Association. The Organizing Association shall supply each visiting Participating Team with the same futsal balls in the amount of seven (7) pieces for the period of its stay.
- 20.2. Participating Teams shall solely utilize the futsal balls provided by the Organizing Association for training and warming-up purposes.

21. Equipment

- 21.1. The CAFA has the sole authority to approve the equipment (including kits) in accordance with the AFC Equipment Regulations.
- 21.2. The AFC Equipment Regulations are operational from the arrival of each Participating Team's Official Delegation at the Match venue until its departure from the Match venue.
- 21.3. All Participating Teams shall declare their first (official) and second kit (reserve) colors during the Match Coordination Meeting, and are obliged to use these colors during their Matches of the Competition.
- 21.4. The CAFA Match Commissioners shall decide on the kit colors (jersey, shorts, and socks) to be worn by Participating Players for each Match based on the equipment information submitted by each Participating Team prior to the Match Coordination Meeting.

SECTION 5: TEAM OFFICIAL DELEGATION

22. Team Official Delegation

- 22.1. Each Participating Team shall ensure that no person in its Team Official Delegation or otherwise affiliated to it enters or is present on its team bus, in its team dressing room, on the Pitch, or in any other Controlled Access Area without being in physical possession of the necessary Accreditation Card which has been validly issued to such person.
- 22.2. Participating Teams shall register a Team Official Delegation, subject to the conditions set out below, comprising of fourteen (14) Participating Players and up to six (6) Participating Officials.
 - 22.2.1. Each Participating Team may nominate a maximum of four (4) additional officials who shall receive the same Accreditation Card as the six (6) Participating Officials referred to above.
 - 22.2.2. All costs related to the additional four (4) officials shall be borne by the relevant Participating Member Association.

23. Eligibility of Players

- 23.1. Each Participating Member Association shall ensure that all players:
 - 23.1.1. are duly registered with the CAFA pursuant to these Regulations;
 - 23.1.2. hold the nationality of its country and are subject to its jurisdiction;
 - 23.1.3. are eligible to participate for the representative team of the Member Association in accordance with the Regulations Governing the Application of the FIFA Statutes.
- 23.2. Individuals who meet the criteria set out in Article 23.1 are eligible to participate in the Competition, subject to the provisions of the AFC Disciplinary and Ethics Code.
- 23.3. Each Participating Member Association shall ensure to submit authentic documents for registration of its Participating Players.
- 23.4. The CAFA General Secretariat may decide not to approve the registration of a player if any of the requirements set out in this Section 5 are not met.
- 23.5. The approval of the registration of a Participating Player by the CAFA General Secretariat does not automatically provide for the eligibility of the Participating Player. Each Participating Member Association is responsible for fielding only eligible Participating Players. Failure to do so shall lead to the consequences stipulated in the AFC Disciplinary and Ethics Code.

- 23.6. A Participating Player shall be deemed ineligible, without limitation, if:
 - 23.6.1. there is a violation of Article 23.1; or
 - 23.6.2. the CAFA determines that any document submitted during registration is falsified or forged.

24. Registration of Players

- 24.1. There are three (3) stages of registration for the players:
 - 24.1.1. <u>Preliminary Registration</u>: each Participating Team must submit a squad of minimum fourteen (14) and maximum twenty-five (25) Participating Players;
 - 24.1.2. <u>Final Registration</u>: each Participating Team must submit a final squad list of fourteen (14) Participating Players comprising individuals registered in the Preliminary Registration;
 - 24.1.3. <u>Player Selection List:</u> each Participating Team must submit a "Player Selection List" prior to each Match which identifies the starting five (5) and up to nine (9) substitutes comprising individuals registered in the Final Registration.
- 24.2. All Participating Players will be provided with Accreditation Cards authorized by the CAFA General Secretariat. Should a card be misplaced and/or lost the relevant Participating Team shall be required to pay USD 100 as a replacement production fee.
- 24.3. Should the CAFA not receive all required documents by the stipulated deadline, the Participating Member Association concerned shall be considered to have withdrawn from the Competition (cf. Article 6) prior to its commencement.

25. Documents for Registration of Players

- 25.1. The following documents shall be submitted to the CAFA for registration of Participating Players:
 - 25.1.1. A colour copy of a valid passport (which shall expire not earlier that 6 months since the date of entry), containing the full name, passport number, place of birth, date of birth, date of issue, date of expiry and nationality of the Player. Group passports shall not be accepted;
 - 25.1.2. A colour copy of a National Identification Card (where applicable);
 - 25.1.3. One (1) passport-size colour photo taken within three (3) months prior to the submission of registration; and
 - 25.1.4. A copy of a birth certificate (when requested).

25.2. All documents shall be free from tampering, and any change or erasure must be endorsed or authenticated by the appropriate authority.

26. Preliminary Registration

- 26.1. Each Participating Team shall submit the supporting documents in accordance with Article 25 via e-mail <u>international@the-cafa.com</u> no later than twenty (20) days prior to the commencement of the Competition.
- 26.2. There is no allocation of jersey numbers during the Preliminary Registration.
- 26.3. Each Participating Team must register a minimum of three (3) goalkeepers in its Preliminary Registration.

27. Final Registration

- 27.1. Each Participating Team shall submit a Final Registration of a maximum of fourteen (14) Participating Players in the Final Registration.
- 27.2. The Final Registration may only be composed of those Participating Players registered in the Preliminary Registration for the Competition.
- 27.3. The Participating Players must be assigned jersey numbers between 1-14. Playing number 1 shall be reserved for a goalkeeper. Each Participating Player shall wear the same playing number allocated in the Final Registration during all Matches in the Competition.
- 27.4. Each Participating Team shall submit its Final Registration to the CAFA by latest seven (7) days prior to the commencement of the Competition.
- 27.5. Each Participating Team must register a minimum of two (2) goalkeepers in its Final Registration.
- 27.6. A player listed on the final list of fourteen (14) players may only be replaced in the event of a serious injury not later than one (1) day before the kick-off of corresponding Team's first Match in the Competition. The Participating Member Association shall immediately nominate a replacement from the preliminary list of twenty-five (25) players and inform the CAFA accordingly. Neither CAFA nor the Organizing Association shall be responsible for any costs incurred due to a player replacement including airfare.

28. Player Selection List

28.1. Each Participating Team shall mark the starting five (5), including the team captain and up to nine (9) substitutes, on the "Player Selection List".

- 28.2. Each Participating Player who is marked on the "Player Selection List" must be available at the "Player and Equipment Check" undertaken by the CAFA Match Commissioner on Match day.
- 28.3. Each Participating Team must submit its "Player Selection List" signed by the Head Coach or the Team Manager, together with the "Officials on the Substitution Bench" form with the names of the six (6) Participating Officials who shall be entitled to sit on the team bench, to the CAFA Match Commissioner by latest ninety (90) minutes prior to the commencement of each Match.

29. Registration of Officials

- 29.1. There shall be two (2) registration periods for the Participating Officials.
- 29.2. During Preliminary Registration each Participating Team may register a minimum of six (6) and a maximum of ten (10) Participating Officials.
- 29.3. During preliminary registration each Participating Team shall submit the following supporting documents via e-mail <u>international@the-cafa.com</u> no later than twenty (20) days prior to the commencement of the Competition:
 - 29.3.1. A colour copy of a valid passport (which shall expire not earlier that 6 months since the date of entry), containing the full name, passport number, place of birth, date of birth, date of issue, date of expiry and nationality of the individual. Group passports are not accepted;
 - 29.3.2. A colour copy of a National Identification Card (where applicable);
 - 29.3.3. One (1) passport-size colour photo taken within three (3) months prior to the submission of the registration;
 - 29.3.4. The CAFA General Secretariat reserves the right to request additional documents in all cases.
- 29.4. Each Participating Team shall submit a Final Registration of a maximum of six (6) Participating Officials during the Final Registration not later than seven (7) days prior to the commencement of the Competition together with the Final Registration of Players as stated in Article 27. Such participating Officials shall be considered as the Team Official Delegation whose full board and lodging together with local transportation will be borne by the Organizing Association.
- 29.5. Each Participating Team may also nominate a maximum of four (4) additional officials in accordance with Article 22. All costs related to the additional officials shall be borne by the relevant Participating Member Association.
- 29.6. Each Participating Team must include the following three (3) Participating Officials in the registration list:

29.6.1. Head Coach;

29.6.2. Team Manager; and

29.6.3. Team Doctor.

- 29.7. Each Participating team is also strongly encouraged to include Team Media Officer in its Registration List
- 29.8. Up to six (6) Participating Officials may sit on the team bench for each Match. The following three (3) Participating Officials must be registered on the "Officials on the Substitution Bench" form:
 - 29.7.1. Head Coach;

29.7.2. Team Manager; and

29.7.3. Team Doctor.

- 29.9. The Team Manager and/or Team Media Officer shall participate in all Official Functions related to the Matches, including without limitation the Match Coordination Meeting and all Press Conferences. They shall be responsible for coordination of all Participating Team's matters with the Local Organizing Committee.
- 29.10. All six Participating Officials (and additional officials) will be provided with Accreditation Cards authorized by the CAFA General Secretariat. Should a card be misplaced and/or lost, the relevant Participating Member Association shall be required to pay USD 100 as a replacement production fee.
- 29.11. Once the Final Registration of the Participating Officials has been received by the CAFA, Participating Team may replace any of the listed Participating Officials not later than three (3) days before the commencement of the Competition, subject to the provision of the relevant documents in Article 29.3. and to the below conditions;

29.11.1. To replace a Participating Official, a Participating Team must provide the official's Accreditation Card to the AFC and shall receive the Accreditation Card of the replacement Participating Official in exchange; and

29.11.2. replacement Participating Officials shall only be eligible to participate in the Competition after receiving their Accreditation Card;

29.10.3. neither CAFA nor the Organizing Association shall be responsible for any costs incurred due to replacement of a Participating Official including airfare.

SECTION 6: FINANCIAL PROVISIONS AND LOGISTICS

30. Responsibilities

- 30.1. The Organizing Association shall cover the following expenses of the Participating Teams representing CAFA Member Associations comprising of fourteen (14) Participating Players and six (6) Participating Officials:
 - 30.1.1. international round trip air-tickets to the Venue or the nearest airport;
 - 30.1.2. board and lodging in a high-standard hotel (subject to Articles 31 and 34);
 - 30.1.3. domestic transportation in the Venue (subject to Articles 31 and 32);
 - 30.1.4. training facilities;
 - 30.1.5. water and refreshments
- 30.2. The Organizing Associations shall also pay for the international round trip air-tickets, board and lodging in a high-standard hotel, domestic transportation in the Venue for the Match Officials, the CAFA Match Commissioners, and any other appointed CAFA Officials;
- 30.3. Any non-CAFA Participating Team shall shall cover all its expenses related to the participation in the Competition including, but not limited to, visa costs, international and domestic travel costs, full board accommodation, domestic transportation in the venue, etc;
- 30.4. The Participating Teams shall not be permitted to stay at the same hotel chosen for the CAFA Match Officials;
- 30.5. The CAFA shall reimburse to the Organizing Association all relevant expenses related to the organization of the Competition upon submission of all financial reports and supporting documents.

31. Arrival and Departure

- 31.1. Each Participating Team shall arrive in the Venue two (2) days prior to the first Match-day of the Competition or by the arrival date determined by the CAFA;
- 31.2. Each Participating Team shall depart from the Venue one (1) next day following the last Match-day of the Competition or by the departure date determined by the CAFA;
- 31.3. Participating Teams shall bear all costs resulting from the early arrival in and/or late departure from the Venue unless otherwise agreed with the CAFA by official communication;

31.4. Participating Teams are prohibited to play any non-official matches during their stay in the Venue.

32. Ground Transportation

32.1. From two (2) days prior to the first Match-day until one (1) day after the last Matchday of the Competition, the Organizing Association must provide for the Team Official Delegation of each Participating Team:

32.1.1. One (1) 30-seated air-conditioned bus with designated driver;

32.1.2. One (1) air-conditioned sedan car with designated driver; and

32.1.3. One (1) equipment truck for airport transfers only when necessary.

33. Visas

33.1. Each Participating Member Association must apply for all necessary visas for their Team Official Delegation no later than thirty (20) days prior to the commencement of the Competition. Visa application costs shall be reimbursed to the CAFA Member Associations after the Competition in exchange of the visa payment receipts of the relevant Participating Team.

34. Accommodation, Meals and Refreshments

- 34.1. Only Official Hotels proposed by the Organizing Association and approved by the CAFA shall be utilized for the Participating Teams' Accommodation;
- 34.2. From two (2) days prior to the first Match-day until one (1) day after the last Matchday of the Competition, the Organizing Association must provide for the Team Official Delegation of each Participating Team:
 - 34.2.1. Accommodation in a high-standard four-star hotel for the Team Official Delegation comprising of fourteen (14) Participating Players and six (6) Participating Officials, which shall include seven (7) double rooms and six (6) single rooms. All rooms, where possible, shall be on the same floor;
 - 34.2.2. one (1) empty room in the said hotel for the purposes of medical treatment and/or equipment storage;
 - 34.2.3. one (1) meeting room in the said hotel (shared between Participating Teams) for the duration of the Competition equipped with a whiteboard and an LCD projector. The meeting room shall accommodate up to thirty (30) persons in a classroom layout setting;

- 34.2.4. three (3) meals per day (international buffet style) in a dedicated dining area for the Team Official Delegation;
- 34.2.5. minimum three (3) liters of bottled water per person per day for the Team Official Delegation, as well as 20 (twenty) kilograms of ice on match days only;
- 34.2.6. daily laundry services (but no dry cleaning or pressing) for six (6) pieces of kits per person per day for the Team Official Delegation; and
- 34.2.7. one (1) liaison officer proficient in English, and preferably the language of the Participating Member Association.
- 34.3. Should the Participating Team decide to be accommodated in a different hotel than those approved by the CAFA, it shall be responsible for all the costs related to its accommodation in a different hotel. It shall also ensure that the Organizing Association is notified on the name and location of such hotel at least one (1) week prior to the Participating Team's first Match in the Competition.

SECTION 7: MEDIA

35. Media Access

35.1. The Organising Association shall ensure that the CAFA, the Host Broadcaster, and all Broadcast Partners have free access to the Stadium from seven (7) days prior to each Match until one (1) day after each Match to allow for the resolution of any technical issues and for the assembly and/or disassembly of the relevant infrastructure required to execute the Media Rights.

36. Press Conferences

- 36.1. The Head Coach of each Participating Team must attend a pre-Competition press conference to be held at least one (1) day prior to the start of the Competition.
- 36.2. The Head Coach of each Participating Team must attend a post-Match press conference for each Match in which they participate, commencing no later than fifteen (15) minutes after the Match. If requested by the CAFA, the Player of the Match of each Match must also attend the post-Match press conference.
- 36.3. Any individual who fails to attend an obligatory press conference shall be fined at least USD5,000. The relevant Participating Team shall also be held liable in accordance with Article 4.2.8.
- 36.4. Each Participating Member Association is responsible for the interpretation of its Head Coach and relevant Participating Players into English. Interpretation into the local language (if applicable) shall be the responsibility of the Organizing Association.
- 36.5. Each Participating Team shall ensure that its selected Official Delegation Member participating in any press conference or interview sessions refrain from making any statements or references which will or are likely to damage or bring into disrepute the good name, image and reputation of the CAFA, Organizing Association(s), relevant Member Association and/or the Competition.
- 36.6. Each Participating Team shall ensure, during any press conference or interview session, that:
 - 36.6.1. the products or other identifiers of their affiliated Member Association or their commercial partners or any associated third parties do not appear and or are not used in any manner;
 - 36.6.2. their Participating Players and Participating Officials do not make any reference to any third-party products or entities.

36.7. In the event the Participating Team's Head Coach is suspended for the Match, the Participating Team shall request the individual replacing the Head Coach on the Team Bench to attend any scheduled press conferences or interview sessions.

37. Mixed Zone

- 37.1. The Head Coach and all Participating Players shall pass through the Mixed Zone on their way from their team dressing room to their bus after each Match.
- 37.2. Any individual who fails to pass through the mixed zone shall be fined at least USD5,000. The relevant Participating Team may be held liable for any failure to pass through the Mixed Zone in accordance with Article 4.2.8. The CAFA Disciplinary and Ethics Committee may impose further sanctions at its discretion.

38. Interviews

- 38.1. If requested by the CAFA, Participating Teams shall make their Head Coach and one (1) Participating Player available the day before each Match for an interview of up to ten (10) minutes, to be recorded by the Host Broadcaster or any other Broadcast Partner, any Commercial Affiliate and/or the CAFA. All interview locations shall be designated by the CAFA Media Officer or CAFA General Coordinator.
- 38.2. If requested by the CAFA, Participating Teams shall make their Head Coach available on Match day for an interview of not more than ninety (90) seconds at their point of arrival at the Indoor Stadium for the Match.

39. Flash Interviews

- 39.1. If requested by the CAFA, any Participating Player (Maximum 3) and/or Participating Officials (Head Coach) shall participate in a 'flash interview' following each Match.
- 39.2. Any individual who fails to conduct a 'flash interview' when requested shall be fined at least USD5,000. The relevant Participating Team may be held liable for any failure to conduct a 'flash interview' when requested in accordance with Article 4.2.8. The CAFA Disciplinary and Ethics Committee may impose further sanctions at its discretion.

40. Team Media Officer

40.1. Each Participating Team in accordance with Article 29 is encouraged to register a dedicated English-speaking Media Officer to coordinate all media arrangements between the CAFA, Organising Association and where applicable, the Participating Team's Players and Officials, the Host Broadcaster and the Media, including without limitation participation in all press conferences and interviews, and to cooperate on all matters related to the Competition.

- 40.2. Each Participating Member Association shall be responsible to ensure that their registered Team Manager and/or Media Officer briefs all Participating Players and/or Participating Officials in respect to their media obligations as required by the CAFA and the Organizing Association.
- 40.3. Each Participating Member Association and their registered Team Manager and/or Media Officer shall be responsible to ensure the provision of translation services where any of the Participating Team's Players or Officials participates in media activities in languages other than English. For the avoidance of doubt, the translation shall be conducted from all other languages into the English language.

41. Recording of Matches

41.1. Organising Association(s) must provide four (4) copies of the Match recording to the CAFA Match Commissioner immediately after the completion of each Match.

SECTION 8: TICKETING

42. General Requirements

- 42.1. Tickets, electronic or hard copy, shall include seat numbering and serial numbering, and only include CAFA Marks, Competition Marks, and/or marks of Commercial Affiliates approved by the CAFA.
- 42.2. The CAFA reserves the right at its sole discretion to substitute the seating area or the gate entrance identified on the ticket with another, if deemed appropriate for security or technical reasons.

43. Terms and Conditions

- 43.1. Each Organising Association shall be responsible at its own cost for the design, production, distribution, and sales of all Tickets. Such matters are subject to the approval of the CAFA.
- 43.2. The Organising Association, in agreement with CAFA, shall determine for each of the Matches:
 - 43.2.1. the total number of Tickets made available in a stadium in which a Match takes place;
 - 43.2.2. the pricing of all Tickets;
 - 43.2.3. the category of Tickets; and
 - 43.2.4. the assignment of Stadium seats to Tickets.

44. Complimentary Tickets

- 44.1. Each Organising Association shall provide Complimentary Tickets to the CAFA for each Match in the Competition as requested by the CAFA.
- 44.2. Each Organising Association shall provide the following Complimentary Tickets to each Participating Team competing at a Venue which it controls for each Match it participates in:

44.2.1. one (1) VVIP Tickets;

44.2.2. two (2) VIP Tickets; and

44.2.3. fifteen (15) Tickets of the next-best category;

- 44.2.4. two (2) Tickets of the next-best category (as determined by the CAFA) for all other Matches at the Venue not involving the relevant Participating Member Association.
- 44.3. Submission of the additional complimentary tickets request by any of the Participating Team does not guarantee the availability of Complimentary Tickets for such Participating Team.

45. Purchasable Tickets

- 45.1. Each Organising Association must make available at least eight percent (8%) of the net saleable capacity of a Stadium available exclusively to the supporters of each Participating Member Association, in a segregated, safe area to be determined by the CAFA and the Organising Association.
- 45.2. The number of Tickets to be purchased must be declared by each Participating Member Association in accordance with the Ticketing timeline and guidelines issued by the CAFA. Each Participating Member Association is responsible for all Tickets purchased, even if not utilised.
- 45.3. Each Organising Association shall provide the CAFA Commercial Rights Partner with the opportunity to buy Tickets at face-value for each Match. The number of Tickets to be purchased must be declared at a time to be mutually agreed between the CAFA Commercial Rights Partner and the Organising Association.

SECTION 9: COMMERCIAL

46. Commercial Rights

- 46.1. The CAFA is the owner of all the Commercial Rights emanating from the Competition as well as from any other related events coming under its jurisdiction, without any restrictions as to content, time, place and law. The CAFA may grant the Organizing Association or any other third party such Commercial Rights in whole or in part.
- 46.2. Participating Member Associations shall provide the necessary assistance and support to the Organizing Association and ensure that members of its Team Official Delegation and associated third parties observe all instructions of the CAFA, CAFA Commercial Partner, and/or Organizing Association in relation to the protection and enforcement of the Commercial Rights or any commercial programme established by the CAFA, CAFA Commercial Partner, and/or Organizing Association in relation to the Competition.
- 46.3. Participating Member Associations and their affiliated Participating Teams shall not oppose and shall use reasonable efforts to ensure that none of its affiliates oppose any trademark or copyright applications filed in respect to the CAFA or the Competition and may not in any way challenge or apply for any copyright, trade mark, patent or domain name registrations which would adversely affect the CAFA's, CAFA Commercial Partner's and/or Organizing Association's proprietary interest in the Competition.
- 46.4. Participating Member Associations and their affiliated Participating Teams shall promptly notify the CAFA General Secretariat of any infringement or suspected infringement of any intellectual property rights relating to the Competition upon becoming aware of any such matter.

47. Image Rights

- 47.1. The CAFA is the owner of all the Image Rights emanating from the Competition as well as from any other related events coming under its jurisdiction, without any restrictions as to content, time, place and law. The CAFA may grant the Organizing Association or any other third party such Image Rights in whole or in part.
- 47.2. The CAFA is entitled to use and exploit all Image Rights relating to the Competition and reserves all rights in respect to the use and/or license of such rights for any purposes, commercial or otherwise, free from any royalty or compensation, in relation to the Competition and grant of rights in relation thereto.
- 47.3. Participating Member Associations and their affiliated Participating Teams acknowledge that participation in the Competition shall automatically be considered as a constitute agreement to the use and/or recording of their image without notice or compensation, and shall indemnify, defend and hold harmless the CAFA, the Organizing Association(s) and any Official Licensees from any and all claims relating

to the use of their images in relation to the Competition and/or grant of rights relating to the Competition.

48. Media Rights

- 48.1. The CAFA owns and is entitled to use and exploit all Media Rights relating to the Competition.
- 48.2. The CAFA reserves the right to withhold or revoke any Media Rights granted at any time prior or during the Competition.
- 48.3. The CAFA reserves all rights in respect to the coordination of all media activities related to the Competition including without limitation the coordination of all press conferences, interviews and release of press statements, as well as selection of designated media areas for the conduction of all press conferences and interview sessions.
- 48.4. Participating Teams' Players and Officials shall participate and provide full support to the CAFA, the Organizing Association(s) and any Official Licensees in relation to any media activities organized by the CAFA.
- 48.5. Participating Teams through their registered Media Officer shall assist the CAFA and where applicable the Organizing Association(s)' and/or Commercial Rights Partner with the coordination of all press conferences and/or interview sessions by ensuring availability and timely attendance of the Team Official Delegation members selected to participate in such media activities.

49. Competition Promotional Material

- 49.1. Prior to the commencement of Competition and/or any Match of the Competition, the Participating Member Associations shall, upon request from the CAFA and/or the Organizing Association, provide photographs and/or audio-visual materials of the Participating Teams' Players and Officials and/or any further information (including without limitation, statistics and historical information) as requested.
- 49.2. All Participating Member Associations hereby grant the CAFA exclusive rights to use and where applicable, authorize the Organizing Association(s) to use the aforesaid provided materials for promotional and/or editorial purposes in relation to the Competition.
- 49.3. All requested materials shall be provided to the CAFA in a timely manner, and in the format requested by the CAFA or its Official Licensees .

50. Clean Stadium

50.1. The Organising Association(s) shall deliver all Indoor Stadiums and Official Training Sites as a Clean Stadium five (5) days before the first Match at each Stadium or

official training at each Official Training Site, until 24 hours after the final Match of the Competition.

51. Advertising and Branding

51.1. The Organising Association(s) shall ensure that all relevant approvals are secured and unrestricted access for the placement and publishing of advertising or branding of the Competition shall be available to the CAFA seven (7) days before the first Match at each Indoor Stadium or official training at each Official Training Site.

52. Official Functions

- 52.1. The CAFA is entitled to exploit all rights relating to the Official Functions and events relating to the Competition and reserves all rights in respect to the organizing and/or staging of such functions or events throughout the Competition.
- 52.2. Participating Member Associations and their affiliated Participating Teams and any third parties associated with the Competition shall not organize any Official Functions or events relating to the Competition without the prior written approval of the CAFA. Any party that wishes to organize and/or stage any Official Function shall provide the CAFA with a detailed plan setting out among others the date, time and venue of the proposed function or event and shall follow and comply with any directions or instructions issued by the CAFA regarding the overall organization and/or staging of the Official Function.
- 52.3. Any approved events or functions shall be organized and/or staged on a noncommercial basis with no sales of tickets or payment from any third party or company and/or no association to the CAFA and Organizing Association(s).

SECTION 10: MEDICAL AND ANTI-DOPING

53. Medical

53.1. It is sole responsibility of each Participating Team to ensure that each player in its Preliminary Registration undergoes a Pre-Competition Medical Assessment ("PCMA") and any necessary medical checks at least thirty (30) days prior to the first Match of the Competition.

54. Anti-doping

54.1. Doping is strictly prohibited. The AFC Anti-Doping Regulations, the AFC Disciplinary and Ethics Code, and all relevant AFC directives in relation to anti-doping are applicable to the Competition.

SECTION 11: | SAFETY AND SECURITY

55. General Principles

- 55.1. All matters relating to safety and security shall be undertaken in compliance with the AFC Futsal and Beach Soccer Stadium Regulations and AFC Safety and Security Regulations.
- 55.2. The Organizing Association shall, in conjunction with the relevant government authorities and/or Stadium owners, devise, plan, and implement adequate security and safety measures for the Competition at all Controlled Access Areas within the Venue and other relevant locations to protect all relevant persons, including without limitation the CAFA Delegation, Team Official Delegations, Organizing Association Commercial Rights Partner, Commercial Affiliates, Media, and spectators, and all goods brought in by the CAFA, Team Official Delegations, Organizing Association Commercial Rights Partner, and Commercial Affiliates.
- 55.3. The Organizing Association shall have a detailed security plan in the form of a binding agreement with, without limitation, the management of all Stadiums, Official Training Sites, and the Accommodation of the CAFA Delegation and Team Official Delegations. Such security plan shall be based upon the principles set out in the AFC Stadium Regulations and AFC Safety and Security Regulations.
- 55.4. The Organising Association shall discharge the CAFA and hold it harmless from all responsibility and relinquish any claim against the CAFA and the members of its delegation for any damages resulting from any act or omission relating to the organisation of the Competition to the exclusion of damages caused by the CAFA or the members of its delegation acting with intent or gross negligence

SECTION 12: DISCIPLINARY

56. Disciplinary Measures

- 56.1. All disciplinary measures in relation to the Competition shall be undertaken in accordance with the current Futsal Laws of the Game, CAFA Statutes, AFC Statutes, AFC Disciplinary and Ethics Code, and any relevant CAFA circulars;
- 56.2. The CAFA may introduce new disciplinary rules and sanctions for the duration of the Competition. Such rules shall be communicated to the Participating Member Associations ten (10) days before the first Match of the Competition.
- 56.3. Only Participating Players and Participating Officials may serve match suspensions during the Competition.
- 56.4. All Participating Players agree to:
 - 56.4.1. respect the spirit of fair play, non-violence, and the authority of the Match Officials;
 - 56.4.2. behave accordingly; and
 - 56.4.3. refrain from doping.

57. Good Conduct

- 57.1. Participating Member Associations are liable for the improper conduct of:
 - 57.1.2. any member of its Team Official Delegation; and/or
 - 57.1.3. any person affiliated to it and/or carrying out duties on its behalf throughout the Competition.
- 57.2. Any sanction issued by CAFA General Secretariat comes into force immediately upon notification.

58. Indiscipline or Violent Conduct

58.1. Each Member Association is fully responsible for its Participating Team's Players and Officials indiscipline or violent conduct at the Indoor Stadium (including without limitation the Team Dressing Room or the Field of Play), Training Sites, places of Accommodation, or any other location within the territory of the Organizing Association.

59. Protest

59.1. For the purpose of these Regulations, a protest is an objection of any kind related to any event and/or matter that has a direct effect on a Match.

- 59.2. Unless otherwise stipulated in these Regulations, to be considered valid, a protest must be:
 - 59.2.1. submitted in writing (using the appropriate Protest Form issued by the CAFA General Secretariat) to the CAFA Match Commissioner for the relevant Match within two (2) hours of the end of the relevant Match;
 - 59.2.2. followed up with a full written report (including a copy of the original Protest Form) which must be sent to the CAFA General Secretariat within twentyfour (24) hours of the end of the relevant Match; and
 - 59.2.3. accompanied by a non-refundable fee of USD 300 (non-inclusive of any bank charges) which must be transmitted to the bank account nominated by the CAFA General Secretariat within twenty-four (24) hours of the end of the relevant Match.
- 59.3. No protest shall be lodged relating to the Referee's decisions regarding facts connected with play. Such decisions are final and binding and not appealable.
- 59.4. If any of the formal conditions of a protest as set out in these Regulations are not met, such protest shall be disregarded. Following the completion of the Final Match of the Competition, all protests shall be disregarded.

SECTION 13: AWARDS

60. Trophy, Awards and Medals

- 60.1. The original trophy of the Competition shall be presented to the Champion during the prize presentation ceremony after the last match of the Competition.
- 60.2. The following awards of the Competition shall be presented in accordance with the Regulations:
 - 60.2.1. Most Valuable Player;
 - 60.2.2. Top Goalscorer;
 - 60.2.3. Best Goalkeeper; and
 - 60.2.4. Fair Play Award.
- 60.3. The CAFA shall award the following medals:
 - 60.3.1. twenty (20) medals to the Champion;
 - 60.3.2. twenty (20) medals to the second place;
 - 60.3.3. twenty (20) medals to the third place; and
 - 60.3.4. commemorative medals for the Match Officials of the last match of the Competition.

SECTION 14: CLOSING PROVISIONS

61. Special Instructions

- 61.1. The CAFA General Secretariat shall, in conjunction with the Organizing Association, issue any instructions necessitated by special circumstances which might arise in the organization of Matches.
- 61.2. These instructions shall form an integral part of these Regulations.

62. Decisions

62.1. All decisions made in accordance with these Regulations, except where expressly identified otherwise, are final and binding and not appealable in accordance with the CAFA Statutes.

63. Amendments

63.1. The CAFA reserves the right to make amendments to any part of these Regulations for any reason whatsoever. Such amendments shall be duly communicated in due course.

64. Force Majeure

64.1. The AFC, CAFA and Organizing Association are the only bodies capable of declaring Force Majeure event.

65. Matters not Provided For

65.1. Matters not provided for in these Regulations shall be decided by the CAFA General Secretariat in conjunction with the Organizing Association. Such decisions are final and binding and not appealable.
